## ACMP *Just Play* Community Concert Grants

ACMP awards small grants to adult amateur ensembles presenting chamber music concerts in their communities, effective July, 2017. The purpose of the grant is to create opportunities for ACMP members and their fellow amateur chamber musicians to showcase work they have rehearsed and prepared in contrast to the play-in experience.

### Program guidelines:

- 1) ACMP will provide \$75 toward space rental and \$25 toward refreshments to ACMP members wishing to present a chamber music performance in their community.
- 2) Each ensemble may apply for up to two concert grants during the fiscal year (August 1 – July 31).
- 3) The lead ensemble member who submits the application must be a member of ACMP.
- 4) The following credit, along with the ACMP logo must be displayed prominently in the program and publicity for the event. The logo is available [here](#).

*This event is supported by ACMP - Associated Chamber Music Players. ACMP is a worldwide membership organization that supports the playing of chamber music for pleasure among musicians of all ages, skill levels, and backgrounds.*

### Before applying:

Form an ensemble. Determine the location of the performance and date and select your repertory. To browse for chamber music online, visit the [Find Chamber Music](#) page on our website.

If you do not have a confirmed program at the time of applying, please give one or two examples of the repertory you will perform.

### Submitting your application:

Submit the application below to the ACMP office via e-mail at least one month before your concert. Exceptions to this schedule will be considered; please contact the Executive Director, Jennifer Clarke, to confirm: jclarke@acmp.net.

### When your application is approved:

Typically, applications are approved within one week of receipt. Payment is made when a report, verification of expenses, and program containing the above credit is submitted to the office, preferably with photos.
